

College Credit Plus is a program that gives students an opportunity to be enrolled in both high school and college course work at the same time. The purpose of this program is to promote rigorous academic pursuits and to provide a wide variety of options to college-ready students. College Credit Plus (CCP) has replaced Ohio's Post-Secondary Enrollment Options program (PSEOP) and all dual enrollment programs.

### How does my child get involved in the program?

\*Students interested in the College Credit Plus program must complete the intent to participate form

\*Students must apply to Edison/Sinclair. Once a student has submitted their application, it is important to contact the College Credit Plus office to schedule a time to take the accuplacer test.

\*IF you have scored a high enough score on the ACT test, the accuplacer test may not be required.

## What happens once I have been accepted?

- \*Student will need to meet with Mrs. Black about scheduling \*Student must attend an orientation at the college they have been
- accepted to
- \* Student will need to register for CCP courses one semester at a time
- \*Student will need to make sure their college and high school schedule coincide

## Athletic Eligibility

It is very important that students work closely with their home school to ensure they are enrolled in the required number of high school and college credits to be eligible under OHSAA rules

Students must be enrolled in courses equal to at least 5 credits.

## Cost

\*Students are limited to 30 college credits per academic year paid for through Tri-Village Schools with participating public colleges or universities. Students wishing to earn more than 30 college credit hours per academic year will be responsible for all costs of attendance for each credit above the 30 credit limit.

\*Students will be charged all fees associated with any course they fail through the CCP program.

#### **CONS OF PARTICIPATION**

- Participation impacts time to be involved in TVHS activities and with friends
- 🗹 Travel time and costs (i.e. bad weather, cost of gas)
- Difference in social maturity between high school and college/adult students
- Parents do not have a right to student information (FERPA belongs to student)
- Failures and withdrawals can impact graduation from high school
- CC+ can impact a student's standing at the high school and future colleges

#### Example Emails

Unfortunately, you were dropped from the online sections of MTH 125 and PLS 121 for failure to pass the online workshop. At this time, only ENG 122 (on campus) remains on your Edison State spring schedule.

If you are interesting in updating your spring registration to include additional courses, please call the Darke County Campus at 548-5546 to schedule an appointment with a success advisor.

\*\*This student needed PLS 121 for graduation and this email arrived in January of the graduation year\*\*

#### Example Emails cont...

Hi everyone,

has just missed his second class in a row (that's 3 out of 5); I've had to advise his team not to count on him for their presentation due to his consistent absences. If he doesn't shape up immediately, I'm afraid he will not pass this course. We are unable to get ahold of him at this time.

\*\*This student needed this course to be eligible to graduate\*\*

#### Example Emails cont...

I don't know if you have been previously contacted by the main campus in Piqua, or not, but I regret to inform you that the ENG 242S course you were scheduled to take in Greenville in spring 2018 has been cancelled due to low enrollment. You will need to put something in its place in order for you to still graduate with your Associate of Arts degree from Edison.

\*\*Student needed this English to graduate\*\*

#### Example Emails cont...

Dear\_\_\_\_\_,

Since it is now mathematically impossible for you to pass EDU 1103. I strongly urge you to drop the class. The deadline for withdrawal is Nov 17.

\*\*Student did not check email on a regular basis and ended up having to pay for this course because they did not receive this notice\*\*

#### Important Notice to Parents and Students

- Students taking CCP courses are subject to the rules and regulations of the university they are currently attending.
- An academic advisor from the participating institution is required to meet with each student within the first two weeks of class. This may be done in a group setting.
- While in college classes, students are introduced to a learning environment that promotes an open exchange of ideas. Course content is presented on an adult level and class discussions require a mature understanding of divergent viewpoints.
- Students should understand that these courses are college-level courses, and the amount of work, pace, and rigor of content in college courses may be much greater than high school courses.
- College course grades become a part of the student's permanent high school and college transcript. Poor performance in college courses may affect future university admissions and financial aid.
- If a student fails any college course, the cost for tuition, fees, and books will be charged to the student and their family. Tri-Village Schools will not pay for any courses that a student has failed.
- Students must meet prerequisite requirements outlined by College they are attending.
- College Credit Plus courses and grades associated with them will be reported on both the student's high school transcript as well as the college transcript.
- College transcripts can be requested by visiting the prospective college website associated with the courses taken. Tri-Village Schools do not have access to college transcripts.
- College Credit Plus does not replace the requirements to earn a high school diploma. Students
  participating in the CCP program, MUST STILL meet all the requirements for a high school diploma. For
  students in the class of 2018 and beyond it is a requirement that students take the end of course exam.

#### Steps and Deadlines

**February 26, 2019**-Informational meeting.

**March**- Apply to partner college (Edison or Sinclair)

**March 30, 2019**- Deadline to complete and return the Intent to Participate form to the Guidance office. **NO LATE FORMS WILL BE ACCEPTED**.

**April-May**- Contact college to take accuplacer test (must have application and transcript). Schedule appointment with partner college and home school guidance counselor to schedule courses.

**April-July**- The college you have applied to will notify you about: acceptance, placement testing, books, orientation procedures, registration, parking etc.

**August**- Notify TVLSD guidance office if you need to adjust your schedule. We will try but cannot guarantee that we will be able to adjust your TVLSD schedule to accommodate your college class.
