

Tri-Village Local Schools School of Excellence Regular Board News Release September 19, 2016

Prior to the regular board meeting Mrs. Kimberly Chowning, Treasurer, discussed the use of federal Special Education IDEA Part B funds and Title funds for the annual requirement.

During the regular school board meeting Mrs. Chowning presented and discussed her synopsis regarding the five year forecast.

Julie Birchfield from Energy Optimizers was on hand to present the energy and facility performance report the school board. Overall the districts electrical consumption is down 20.3% and gas consumption is down 33.1%. The districts actual savings for the 8 month period is \$24,473.

Mr. Shane Mead, Elementary Principal and Mr. Lee Morris, JH/HS Principal discussed the districts Local Report Card and shared ideas moving forward to help staff and students understand and achieve the benchmarks that the state has set forth. Mr. Mead is excited to have Mr. Ron Bauman on staff as a Title I Coach due to his large amount of experience in education. Mr. Bauman recently worked for ODE was a mentor on the PARCC testing committee. Mr. Bauman was recently an ELA liaison who went in to school districts and provided professional development on how to decode the standards. Mr. Mead and Mr. Morris both purchased resources to use on decoding the standards, and both are eager to dive in and move forward. Elementary students will continue to be a part of afterschool intervention. This is for any students wanting and needing extra assistance. The goal is to give our students as many opportunities for assistance as possible.

Mr. Morris explained the junior high/high school has expanded intervention opportunity for all students in grades 7 and 8. All year seventh grade students will have an intervention fourth period in which teachers focus on certain tested areas. Eighth grade students will have the same opportunity with an intervention period once a semester.

Graduation Component, our kids are still graduating at a high rate. Prepared for Success Grade – high school students had the option to take an ACT prep course all year long. All students taking this course will take the ACT test, paid for by the District. Additionally, all juniors will now take the ACT compliments of the State of Ohio. The Progress piece is the most important to all administrators. If we can show a year's worth of growth that to us shows that our kids are showing growth and learning each year. We believe we do more for our kids in a year than a one day assessment will ever indicate.

Mr. Sagester reported on the 2015-2016 Local Report Card release date. Below is a summary of the grades received on this year's report card. A review of the other local districts and school districts throughout the state will still show Tri-Village students are making significant progress. Of the 608 school districts in Ohio, Tri-Village was 1 of only 114 districts to earn an A on the progress component and 1 of 329 to earn an A on the graduation component. Of the 608 school districts in Ohio only 283 received a higher grade than Tri-Village in the Achievement category (we were at or above the state average in 19 of the 24 indicators where a state average was released) and only 82 on the Gap Closing component. With that being said, of the 608 schools, 526 earned an F on the Gap Closing component. While the district scored an F on K-3 Literacy component, only 110 of the 608 districts scored in the A-C range. Finally, Tri-Village was 1 of only 261 schools to score a D on the newest component, Prepared for success.
