Tri-Village Prepares for New State Requirements

Tri-Village Local Schools continues to work toward aligning its methods with the Common Core Curriculum that is to be in place for the 2014-15 school year. The most recent requirement is the Third Grade Reading Guarantee that strives for all students to be proficient readers. As part of Ohio Senate Bill 316, which was signed into law in June, all students who enter the third grade in must score at a certain level on Ohio's third-grade reading achievement assessment to be advanced to the fourth grade.

Beginning this school year, each district must administer a language arts diagnostic assessment to students in kindergarten through third grade to identify those who are reading below grade level. Tri-Village completed this task, and notified parents.

The Ohio Department of Education (ODE) has also listed a sequence of actions that must be taken for students who perform below their grade level, including specialized teachers, 90 minutes of reading per day and an improvement plan to bring them up to speed. Mr. Sagester and the elementary teaching staff have fully implemented a plan and a method to report the student intervention to the Ohio Department of Education.

The plan Tri-Village is using is not fundamentally different than past practices. The district had already implemented Measures of Academic Progress (MAP) testing prior to the new law taking effect this year. Alongside the testing Tri-Village had already developed intervention plans to assure that students struggling with reading were receiving extra help. The district did develop a plan on how to document the interventions the teachers are providing so that reports can be submitted to ODE.

Students may be held back in only reading but may advance to fourth-grade level coursework in other subjects. Most school districts do have some type of monitoring program in place to keep an eye on students who may be falling behind. For Tri-Village, the district currently gives all students in kindergarten through twelfth grade a diagnostic screening assessment three times per year. "The third grade reading guarantee will only make our current practices stronger," Superintendent, Tony Thomas said. "We are always looking for ways to improve the achievement of our students. This year we are working with individual grade levels on rolling out the common core standards and implementing effective teaching practices."

"Funding may be a concern of the requirement," Thomas added. "Many of the provisions in the third grade guarantee are still being developed by ODE. Therefore, we are not certain of the cost implications, or whether this will become another unfunded mandate from ODE," he said.

In addition to the Third Grade Guarantee, Tri-Village will also continue work toward online assessments for students, another requirement of the Common Core. According to ODE's website, the online assessments will use multiple measures including multiple choice, constructed response, technology-enhanced items and tasks, take measures of student progress at intervals during the school year, and use automated scoring processes that provide real-time results. Data and field testing will continue in Ohio schools through the 2012-13 school year, with implementation of online assessments expected for 2014-15.

The district will also look to align their teacher evaluations with Common Core requirements. Tri-Village Schools will begin a test round of new teacher evaluations that will measure a teacher's performance on two tiers. Half of the evaluation will be based on student academic growth, and the other half will be directly related to the instructor's performance. This style of evaluation is what will be required by ODE as part of the Common Core. Thomas added, "This is a very rigorous evaluation process, and we think that's a good thing, that it's rigorous, and we think teachers will think it will be a good thing that it's rigorous," he said. "We believe in our staff and we know they will meet the challenge."
