

## Tri-Village Local Schools School of Excellence

Regular Board News Release July 31, 2017

The Tri-Village Local School District Board of Education met in special session on Monday, July 31, 2017 at 5:45 p.m. with the following members present: Tim Bevins, Shane Coby, Darin Dubbs, Amy Farmer and Tom Schlechty. Administrators attending were Josh Sagester and Kimberly Chowning.

At 5:45 p.m, the Board of Education held a special meeting which consisted of a public meeting to consider the reemployment of retirees for the 2017-2018 school year. Employees considered were Teresa Light (Bus Driver) and Ann Brubaker (Food Service). These two individuals will be on the August agenda for rehire.

The regular Board of Education meeting began at 6:00 p.m. The regular meeting minutes for June 26, 2017 were approved. The members also approved the June 2017 expenditures, current appropriation budget amendments and all financial reports as presented by the Treasurer.

Superintendent Report: Mr. Sagester shared that an Administrator's Retreat will be held August 3 and 4 at Miami University. New teacher orientation will take place on August 14. The first and second teacher work day will be on August 15 and 16. Many professional development opportunities will take place on these two days including Technology Integration (SOITA), Data Analysis, AED training, speaker Marilyn Swartz (Differentiation, Strategies and the RTI system), ESC Curriculum personnel will be present, Navigate Prepared training and Restraint and Seclusion Training (Jodi Fritz). The third teacher work day, August 28, will include a motivational speaker, David Crone. Open House is the evening of the 28<sup>th</sup> with students officially arriving on campus, August 29. Amanda Dyson, Youth Advocate, will return to the District this year. This position is funded by the Community Connectors grant which is spearheaded by Jeff Vaughn, Council on Rural Services. Mr. Sagester informed the Board members that per ORC 3313.814, the District's food service program has adopted and continues to enforce a nutrition standards policy (Board policy number 8500 and 8500A). House Bill 410 was discussed. This is a truancy policy and updated information will be placed on the District's website. Grades 4 and 6 Social Studies assessment tests have been eliminated for the upcoming school year. Graduation requirements for 2018 only were shared which consist of two options. The first option requires all students to take all required high school courses, end of year course exams, and meet two of the eight following conditions: 1) Senior year attendance rate of 93 percent, 2) 2.5 senior year GPA based on taking at least four full-year courses, 3) Senior capstone project completion, 4) completion of 120 hours of work/community service, 5) earning three or more credits in a College Credit Plus course, 6) successful completion of Advanced Placement or International Baccalaureate, 7) reaching minimum cut scores on sections of the WorkKeys assessment and 8) meeting the conditions to earn an OhioMeansJobs – readiness seal. The second option is specific to career-technical students. Mr. Sagester shared the 2016-2017 AIR achievement results. The District was above the state average on 15 of the 23 tested categories. The Pre School program has received a 4 Star rating from the Ohio Department of Education. Superintendent Sagester publically thanked Jared Rush, Athletic Trainer, who has accepted another position. Mr. Rush will be replaced by Pat Snyder. Mr. Snyder is a graduate of Northmont High School and Ohio University. A facility and technology summer update was shared. Many items have been completed with a few remaining. Extracurricular dates for the Fall season scrimmages, games and meets were shared along with a list of the Fall coaches.
