



Tri-Village Local Schools
Board News Release

The Tri-Village Local School District Board of Education met in regular session on Monday, July 29, 2019 at 6:00 p.m. with the following members present: Tim Bevins, Shane Coby, Amy Farmer, Tracy Frech and Tom Schlechty. Josh Sagester and Kim Chowning were present as well. The minutes of the regular meeting for June 24, 2019 were approved. The members also approved the June 2019 expenditures and all financial reports as presented by the Treasurer.

Superintendent Report: The administrators will be attending their annual retreat at Miami University on August 4 and 5. New teacher orientation will be held August 12 and the first and second teacher work day is August 13 and 14. During the third work day on August 26, Speaker Chad Willett (“Smash the Box”) will address the staff. Open house will be held that evening as well from 5:30 to 6:30. The first day of school for students is Tuesday, August 27. Parent and student training dates and times have been established for chromebook care and internet safety the week of August 12. Mr. Sagester informed the members that the Food Service department has adopted and continues to enforce the District’s nutrition standards policies (policy numbers 8500 & 8500A). In legislative news, Governor DeWine has appointed Steve Dacklin and Reginald Wilkinson to the State Board. Both appointees are Columbus residents. School foundation funding simulation dollar amounts were shared. The incoming freshmen, Class of 2023, will graduate with new requirements which eliminates the English I end of course exam and the elimination of Geometry is pending. Currently, 64 pre-school students are enrolled for the upcoming school year. Mr. Sagester gave a facility and technology summer update as well as an extracurricular update. We wish Chelsea, Athletic Trainer, well as she leaves the District on August 10 to move to Columbus. Mr. Sagester and Mr. Gray are working with Wayne Healthcare on her replacement. The fall parent meeting will take place on August 7. Extracurricular dates for the fall season scrimmages, games and meets were shared along with a list of the coaches.
