The Tri-Village Local School District Board of Education met in regular session on Monday, November 21, 2022, at 6:30 p.m. with the following members present: Tim Bevins, Shane Coby, Darin Dubbs, Tracy Frech, and Tom Schlechty. Josh Sagester and Kim Chowning were in attendance as well as Heather Brown (community member).

The Board members approved the minutes for the regular meeting held on October 17, 2022.

Superintendent Report: Occupancy was granted on November 18 for the Patriot Activity Center. There are still several punch list items for the PAC and Early Learning Center to be completed. Personnel from Level MB will remain on site to work through these items, particularly the atrium flooring and imperfections in the gym floor as well as issues with speakers, student section steps, and ceiling tiles. Behr Design, LLC has provided a quote to update the wayfinding signage which will be installed in the spring at the latest. Mr. Sagester was happy to announce that over thirty veterans attended the Veteran's Day program on November 11. Mr. Morris, Mrs. Black, Mr. Mead, Mr. Bialowas, Mr. Wirrig, Joanie Hollinger, and the kindergarten teaching staff spearheaded the event. The high school student council and FFA also provided a breakfast for our service men/women. The National Honor Society induction took place on November 9 and the following students were inducted: Torie Richards, Haylee Potter, Kiersten Wilcox, Nataleigh Koontz, Macy Howell, Josh Metzcar, Taylor Begoon, Lydia Ayette, Trey Homan, and Grace Bergman. Congratulations to all these students! Mr., Sagester reviewed value added teacher reports with are identified in three sections: 1) significant evidence that the teacher's students made more growth than expected, 2) evidence that the teacher's students made growth as expected, and 3) significant evidence that the teacher's students made less growth than expected. All Southwest District honors include First Team (Braden Keating – Offensive Player of the Year, WR Tanner Printz, RB Reed Wehr, OL Dillan Plush, OL Blake Weyant, DL Seth Cook, LB Austin Rismiller, and DB Justin Finkbine) and Honorable Mention Christian Cantrell. The girls' basketball season opened in the PAC on November 18 against Chaminade Julianne. There was a very large crowd in attendance! A boys' scrimmage will take place at home on November 26 versus Greenview.
